SECTION 4: First aid measures

4.1. Description of first aid measures

Take care of your own safety. If any health problems are manifested or if in doubt, inform a doctor and show him information from this safety data sheet. If unconscious, put the person in the stabilized (recovery) position on his side with his head slightly bent backwards and make sure that airways are free; never induce vomiting. If the person vomits by himself, make sure that the vomit is not inhaled. In life threatening conditions first of all provide resuscitation of the affected person and ensure medical assistance. Respiratory arrest - provide artificial respiration immediately. Cardiac arrest - provide indirect cardiac massage immediately.

Inhalation

Skin contact

Remove contaminated clothes. Wash the affected area with plenty of water, lukewarm if possible. Soap, soap solution or shampoo should be used if there is no skin injury. Provide medical treatment if skin irritation persists.

Eve contact

Rinse eyes immediately with a flow of running water, open the eyelids (also using force if needed); remove contact lenses immediately if worn by the affected person. Rinsing should continue at least for 10 minutes. Provide medical treatment, specialized if possible.

Ingestion

DO NOT INDUCE VOMITING! If the affected person vomits, make sure to prevent inhalation of the vomit (as there is a danger of lung damage after inhalation of these liquids in the airways also in infinitesimal amount). Provide medical treatment considering the frequent need of further observation for at least 24 hours. SECTION 5: Firefighting measures
